# **President's Report**

- 2024-25 was a special one for the club with 2 Senior and 4 Junior premierships.
- Players benefitted fully from the Blackman Park nets lighting infrastructure upgrade, enabling players to train at night.
- Thanks to the committee who prepared for the 2024-25 season well in advance, including recruiting 3 overseas imports, who went on to make a significant contribution throughout the season, both playing and coaching.
- For the first time in 17 seasons, the club's u24 team qualified for the semi finals, and proceeded to claim the Frank Gray trophy, defending 260 at Weldon against Warringah in the grand final.
- Further, our first grade side won the Limited Overs competition, our first in the second season of the competition, playing away against Mt Prichard Southern Districts, and comfortably chasing 210 off the back of skipper Michael Byrant's batting.
- The club receives great support from our sponsors, Belle Property Lane Cove, LBD Landscaping, Kingsgrove Sports and Kingston Financial, who I'd like to express our sincere thanks to.
- A special mention to Andrew Bray who stepped up as "Vice President Seniors", and ran the Seniors with a no fuss, can do attitude.
- The Juniors under new "Vice President Juniors" Bevan Guest, increased numbers to 290 players and 35 Junior Blasters.
- Along with the great participation, the Juniors had great results, including winning two under 10 boys and two girls premierships.
- Plans are well under way for the 2025-26 season, with the goal that more Seniors will commit to playing which will help keep Senior Subscription fees in check.
- A particular point to note from our financials is that the club spent nearly \$100,000 in Council fees, something that needs active management to control.

- Consequently, the club needs to unite or die, as it becomes progressively harder and more complex each year to run the club.
- Nevertheless, we thank Lane Cove Council for all their support and work on grounds last season.
- With new covers at Tantallon and a new small cover at KSO in the pipeline, we look forward to improved pitches in the upcoming season.

# **Financial Report**

- Financially, LCCC had a difficult season in 2024/25.
- Revenue was \$178k, with a net loss of \$31k.
- Junior player numbers increased slightly while Senior player numbers stagnated.
- Overall, player subscription fees increased slightly to \$134k.
- While revenue increased from \$142k to \$178k, club expenses increased too.
- After adjustments to the operating result from grants, donations and prior year expenses, the result was a net loss.
- Ground hire was \$98K, up from \$43k.
- Equipment and balls was \$32k.
- NSJCA registration fees were \$37k.
- There was also a \$26k prior year ground hire adjustment.
- Grants were \$23k and Donations \$11k.
- Despite the loss, the Club maintains a solid cash reserve of \$92k, and net assets of \$79k, reflecting prudent historical management.
- Looking ahead, the Club faces a number of significantly increasing expenses.
- Ground hire, which has more than doubled in recent years, is expected to rise further.
- NSJCA fees continue to trend upwards and are expected to increase a further 10% in 2025/26.
- Shires Umpiring Fees, which Cricket NSW have advised they will not be paying for anymore, will be an additional expense for the club.
- These expenses represent structural challenges to the club's financial model.
- The committee is proactively reviewing cost drivers and remain committed to keeping cricket affordable and accessible.
- However, fees may have to increase further in coming seasons if the increased costs can't be absorbed through other efficiencies or increased external funding.
- Nevertheless, the club is maintaining Senior registration at \$700 and Junior registration at \$425 (excluding other fees from Cricket Australia, Cricket NSW and NSJCA).
- Maintaining healthy registration numbers and securing ongoing support from sponsors and donors will be essential in offsetting financial headwinds.
- Yet the Club remains well positioned for growth, building off the hard work of club administrators over many years, resulting in the Club having access to some of the best playing and training facilities in Sydney.
